
2026 Strategic Projects:

1. Digital Resource Expansion

- **Creation Science Video Series:** We will expand our library of 40+ videos covering geology, evolution, the fossil record, and genetics. These resources emphasize intelligent design and demonstrate the harmony between scientific evidence and God as Creator.

2. Multimedia Outreach

- **Bible Vignettes:** Production of 5-to-10-minute videos addressing contemporary issues from a biblical perspective. Each vignette will include links to deeper study resources.
